
Philanthropy Day

A Matter of Relevance

When I'm out and about and someone asks the question "What do you do?" I usually respond by smiling and saying "I help keep the Carmel Public Library open, relevant and thriving." After which, I am typically met with two types of responses.

#1. "That's so wonderful. Libraries were such an important part of my childhood." OR....

#2. (sarcastic) "They still have those around?"

While response #1 is reaffirming, I believe it is incumbent upon me to address the latter which speaks to relevancy. This seems to be a two-fold issue; one is our ability to convey to our current and potential constitutents that our library offers benefits beyond books; free

language programs, kid's and adults summer reading programs, community programs, college and financial aid services, etc. Efforts to market these offerings through low-no cost channels over time should increase awareness and confirm our value proposition. Wonderful – problem solved.

The other issue is a bit more complicated.

First we have to acknowledge, no…embrace the fact that libraries are changing and I don't just mean they're integrating technology – that change has been happening for decades. The change is more profound. How do we evolve our role to continue to serve the needs of our community? And in order to answer that question we need to address how we define community. Ours is comprised of a percentage of residents, second home occupants, and tourists and within each of those sets are subsets with varying demo and psychographics. For example, our library attracts 20% of its youth patrons from the neighboring town of Pacific Grove. Are those children part of our community?

As I ponder the question of community I wonder is it based on zip codes or a mindset? Do you have to have been born here? Is there a length of time spent in Carmel that qualifies you as a local? When I asked one of our residents to reflect on our library relative to our community, she said "The library isn't part of our community, it is our community." I agree that our library is much more than a repository of knowledge. It is also a social destination where deep connections are made that foster a sense of well-being and belonging—a place where everyone is on equal footing the moment they step inside.






It's all in the conversation

with Library Director Ashlee Wright

Q Tell us about the Harwood Conference you attended. This past spring the Library received a grant from the Harwood Institute Public Innovators lab to help libraries build the foundations for understanding community, being turned outward, creating the conditions for change and sustainability, and deciding on the right path to implement those changes through conducting community conversations.



- 1. The importance of seeking out public knowledge, its value, and its difference from expert knowledge.
- 2. The importance of being turned outward into the community which is the act of seeing and hearing those in the community, and acting with intentionality to create change.
- 3. The importance of being aware of the stages of community life in order to identify the right conditions to accelerate and support change.

What are your plans for thes community conversations? In the Fall library staff will be engaging different and diverse groups in community conversations seeking to understand the community's aspirations for itself, the challenges inherent in reaching these aspirations, and the changes needed in the community to reach these aspirations.

What can our community expect when they're completed? We will be sharing what we learned and how it can help make our work in the community more effective, and using what we learn to help inform the library's strategic planning process.



"Welcome to our library!"




